## AWARD

- **TWENTY-FOUR (24)** winners will be selected to receive a **\$1,000 Scholarship** for their post-secondary education
- Each winning recipient's **Sponsoring Teacher** will receive a **\$200 Award**

## ELIGIBILITY

- Graduating Senior of the 2024-2025 school year
- Current grade point average of 2.5 or higher
- Demonstrate academic excellence and school / community involvement
- Enroll in an accredited two-year or four-year college, university or vocational / technical school for the 2025-2026 academic year
- Member of Jefferson Financial FCU upon awarding

*\*Credit Union employees, related to Credit Union employees, Board Members, and related to Board Members are NOT eligible to participate.*

## PACKET REQUIREMENTS CHECKLIST

- Completed **Application** (available at JeffersonFinancial.org)
- **Official High School Transcripts** from your counselor's office (may be mailed separately)
- **Resume / Extracurricular Activity List** (during high school years only) of extra-curricular clubs, sports, community service / volunteer organizations, work experience, etc. Note the number of years participated and any leadership roles held in each
- **Essay** - 300 - 500 words using the fillable Essay Form attached - choose ONE (1) of the following topics:
  - Describe a financial hardship that you've overcome. How has it changed your outlook on financial responsibility?
- **OR**
- Explain how your previous (or current) community service work / involvement has impacted you.
- **One (1) Letter of Recommendation** from a member of the community, teacher or mentor who is not related to you  
*(may be mailed separately)*

## SELECTION

- Applicants will be reviewed and judged by the Jefferson Financial FCU Scholarship Committee
- Incomplete or late application packages will not be accepted
- All Applicants will be notified whether or not they are a Scholarship Recipient by **Friday, June 6, 2025**

*It is crucial that we know the decided university, college or vocational school in order to issue your check. You must deposit this check directly into your university or community college account. Contact the Bursar's Office and they will explain how to deposit the check. You cannot deposit this check into your person Credit Union account. Checks are good for 90 days.*

- **Sponsoring High School Teacher Checks** will be mailed no later than **August 1, 2025**.

*We request all applicants to include a reliable email address for sponsoring teachers so we can confirm a mailing address. Checks are good for 90 days.*
